Who can apply?

- ⇒ Applicants must be a member of a PTA/PTSA that has been a unit in good standing during the 2016/17 term (met all requirements specified in the bylaws, which includes remittance of roster, per capita, and insurance premium to Fifth District, through channels, by the established deadlines.)
- \Rightarrow Applicants must be elected by the PTA/PTSA general membership as a delegate authorized to represent the association.
- ⇒ Applicants must attend the convention in its entirety (Friday, April 28 thru close on Sunday, April 30) and register as a Voting delegate.

How do we apply?

- \Rightarrow Complete the 2017 Convention Scholarship application and submit to Fifth District **before Noon March 13, 2017**.
- \Rightarrow Register for Convention before March 31, 2017.

How many Scholarships will be awarded?

 \Rightarrow Fifth District PTA will award up to four Scholarships.

Can a unit or council get more than one scholarship?

 \Rightarrow Scholarships are limited to one per unit or council; two units in the same council may receive scholarships.

When do we find out who will be awarded a Scholarship?

 \Rightarrow Recipients will be notified on March 15, 2017 via email.

What is our requirement at Convention?

Elected delegates are obligated to attend ALL meetings and assigned conferences.

What is our requirement after the Convention?

⇒ After Convention, submit to Fifth District PTA a brief summary on how your attendance at the California State PTA Convention was beneficial and attach copies of receipts. The summary and receipts must be <u>received</u> by May 25, 2017.

When can the PTA expect to receive the Scholarship funds?

 \Rightarrow A check will be written to the PTA upon receipt of summary and receipts. If summary and receipts are not received at the Fifth District PTA office by the deadline date than the scholarship will be considered void.

All Applications must be <u>received</u> by Noon March 13, 2017
